- A maximum of three (3) nexus questions can be submitted for a Risk Assessment if
  the questions cross multiple medical specialties. And, if multiple medical specialties
  are evaluated in the Risk Assessment, multiple expert nexus opinions might be
  required should the Attorney decide to move forward.

- Provide Medical Records through a MedConnectVA Shared Folder and please remember to notify us via email when the medical records have been transferred.
- If you do not currently have a shared folder with MedConnectVA, this will be identified in the Risk Assessment Request form (link above), and we will contact you to set it up. It takes about 5 minutes.
- Risk Assessment Reports will be delivered in 30 days or less.
- You can pay for Risk Assessments either by check or credit card. We will email an invoice immediately upon receipt of a Risk Assessment Request.











The link to our Credit Card Processing facility will be included with the invoice so that you or your clients have multiple payment options. Administered by PayPal, our credit card service is highly secure. We accept major credit & debit cards, and you can also choose to use your PayPal account if you have one. Please note: A 3% fee is added to all credit card transactions to cover the cost of the service.
